# The so-called Third Generation Programme

# A global vision

The general objective of Community action is the achievement of a common cultural area through the development of cultural cooperation in Europe. This action will thus contribute actively to the development of a European identity from the grassroots.

# The Specific Objects

- § Supporting the transnational mobility of people working in the cultural sector
- § Encouraging the transnational circulation of works of art and artistic and cultural products
- § Promoting intercultural dialogue

### Parliament Committee on Culture and Education

EU cultural committee is responsible for:

- 1. the cultural aspects of the European Union, and in particular:
  - a) improving the knowledge and dissemination of culture
  - b) the protection and promotion of cultural and linguistic diversity
  - c) the conservation and safeguarding of cultural heritage, cultural exchanges and artistic creation
- 2. the Union's education policy, including the European higher education area, the promotion of the system of European schools and lifelong learning;
- 3. audiovisual policy and the cultural and educational aspects of the information society;
- 4. youth policy and the development of a sports and leisure policy;
- 5. information and media policy;
- 6. Cooperation with third countries in the areas of culture and education and relations with the relevant international organisations and institutions.

The CULT Committee has recently begun work on the Commission's proposals for the next generation of education, culture, youth and media programmes. The Rapporteur for Culture (€ 408 million for seven years proposed by the Commission) is MEP Graca Moura.

The President of Parliament - Chair of the Temporary Committee on Financial Perspectives - has written to the chairmen of the permanent committees suggesting that the legislative process can continue, but there should be no discussion in plenary of the budgets of future multi-annual programmes until after the Temporary Committee has reported [see Communication from the Commission to the Council and the European Parliament on Financial Perspectives 2007–2013, *COM* (2004)0487 of 14 July 2004]. The Temporary Committee will report to plenary on 11 May 2005 and the CULT Committee can then proceed to adopt reports on the four proposals for co decided programmes. Parliament's first readings on these proposals might take place in September 2005.

The Council will then have to try to reach common positions. Absence of an agreement within the Council on the next Financial Perspective would cause a long delay before these common positions were agreed and this would in turn slow the start of the new generation of programmes.

The Luxembourg and UK Presidencies will make every effort to reach an agreement on the new generation of Culture Programme 2007–2013. The decision on the programme can not be taken before the budget is adopted.
