#### **EBLIDA Strategy and Work Programme**

EBLIDA followed its EBLIDA Annual Work Programme 2004 – 2005, based on the EBLIDA Strategy 2004 – 2007 document. EBLIDA worked hard on having its voice heard in EU context on library and archive issues. Mainly through its Working Groups responses to EU Directives and documents were prepared and lobby activities initiated.   - According to the Commission, the first experience with the Recommendation shows that EU-wide licensing actually works. The first EU-wide license was conceived just three months after the Recommendation was adopted. On 23 January 2006, EMI Music Publishing announced having entered into a Heads of Agreement with the MCPS-PRS Alliance (the UK Collection Society) and GEMA (the German Collection Society), with the aim of offering to license the rights in EMI MP's Anglo-American songs under a single license across Europe for Mobile and On Line Digital uses. On 20 January 2006, the UK society (PRS) has formed a joint venture with the Spanish society (SGAE) that creates a platform for future joint EU-wide licensing of the Anglo-Hispanic repertoire.

# EBLIDA Copyright Expert Group

The Copyright expert Group held two meetings, on 3-4 March in Cambridge (England) and on 28 October in Aarhus (Denmark). It discussed many issues, the most important of which are listed below (with a reference to any official statement by EBLIDA):

- schemes to make published material more easily usable by visually-impaired people (especially when the published material is protected by technical systems)
- data protection issues arising from technical protection systems (associated with intellectual property rights)

Members of the group have also held useful meetings with officials and other lobbyists. On 7 October, Wilma Mossink and Nol Verhagen met Mr Xavier Troussard, adviser on culture and communication to EC Commissioner for Education and Culture Jan Figel. On 22 November Chair Toby Bainton attended a public hearing at the European Parliament in Brussels on the subject of criminal measures to enforce intellectual property rights. And in July, September and November Barbara Stratton (in November with Harald von Hielmcrone) attended meetings of the World Intellectual Property Organisation or its committees. Meetings to discuss topics of common concern were also held with the Federation of European Publishers on 15 June and 23 November.

## **EBLIDA Working Group on Professional Education**

The Professional Education Working Group (PEG) which has a brief to monitor professional education and qualifications on behalf of EBLIDA has met twice during the year and spent time cementing relationships with other like minded bodies. Most of the Group's work has been to investigate production of a document stating EBLIDA's position on LIS and Archive professional qualifications as part of a proposal to develop a Common Platform for the library and archive sector under Article 15 of the Directive on the Recognition of Professional Qualifications.

The complexity of the education situation in Europe is widely acknowledged and it is recognised that sharing information on education issues is an important aid to lobbying. For example on the Recognition of Professional Qualifications Directive, the Lifelong Learning (LLL) Framework, the Bologna Process (both training of professionals and activities of LIS and Archive professionals in training students in universities), Digital Libraries and Certification process.

At its meeting in January 2006 PEG agreed that creation of a common platform (Article 15) would encourage professional associations to participate in the Bologna Process (BP). Although the Directive relates to regulated professions and does not directly affect LIS and Archives, it is seen as a positive driver and presents an opportunity to improve the sector's profile.

In discussion on what the content of a common platform for the sector might look like, PEG agreed that information should be gathered from members. This will be equally important for lobbying activities to help better understanding of the profession – image, pay and status etc. It would also avoid duplication of existing work such as that of Certidoc, which has just produced a revised version of its documentation.

PEG agreed that the process of establishing a common platform, even if it is not finalised, will help to identify the complexity and breadth of the sector and will in itself increase confidence in understanding what we do. Undertaking such a process would allow us to use the definitions as a basis for promotion to non LIS and Archive sectors.



# **EBLIDA Working Group on Trade Agreements and Libraries**

The most important event in 2005 was the seminar "Trading in Knowledge", organised in Cambridge on 2-3 March by EBLIDA and SCONUL in cooperation. Twenty-five people from twelve countries participated. The speakers included, i.e., the celebrated English author and journalist George Monbiot, and GATS counsellor Dale Honeck.

The second day of the seminar focused on practical action. It was suggested that the expert group change its name to the current one, and that a statement be written to summarize EBLIDA's views on the potential implications of trade agreements on publicly funded libraries. I was also pointed out that intellectual property rights have developed into a large trade area, and that this calls for a degree of cooperation with the EBLIDA Copyright Expert Group.

In conjunction with IFLA's annual conference in Oslo the group met at Oslo University College to discuss, i.e., library representation at the upcoming WTO Ministerial in Hong Kong, and the EU proposal for a Directive on Services in the Internal Market. Also, the chairman Kjell Nilsson gave a talk at an IFLA/CLM session, giving an overview of the issue of trade and libraries.

In September a Position Paper on trade agreements and libraries was finalized:

Due to lack of funding, nobody from the group was able to attend the WTO Ministerial in December. According to a report from the IFLA delegation nothing of immediate interest to libraries seems to have occurred.

In January members Bainton and Hielmcrone met with a member of the European People's Party to find out more about his interpretation of the EU proposal. The results of that conversation and of recent changes to the proposal seem to suggest that publicly funded libraries are not immediately threatened.

The group was considerably strengthened in May 2005, in conjunction with the EBLIDA Council in Cork, Ireland, by the addition of three extra members.



# EBLIDA Projects

#### **European projects**

EBLIDA participated in the 2-year project CALIMERA, focusing on cooperation of local libraries museums and archives. This project ended in May 2005. Benefits have been the visibility of EBLIDA in Europe, establishing new contacts and working relations. It also offered some financial relief, but required much extra efforts from the staff.



# **EBLIDA Organisation and Membership**

EBLIDA welcomed member organisations from new EU Member States, and made some welcoming regulation for membership and policy to organise annex meetings in these states. Due to organisational restraints, the meeting had to be postponed.

The EBLIDA membership remains a fragile factor in the lobby organisation, as many associations have a very limited budget for international memberships and lobby activities.

The EBLIDA Office recruited a new administrative staff member in the vacancy. At the end of the year it became also clear that a new director would have to be recruited from the 1st of February 2005. An interim solution could be found through support of the EBLIDA host organisation in the Netherlands.
